## **BUSINESS GROWTH MARKETPLACE: KEY DETAILS**

WHEN: The Business Growth Marketplace (BGM) is taking place on **Tuesday, December 12th** from **1:15 - 5 PM ET**. All vendors should report to their assigned booth in the pre-function area for set-up by **12:00 pm ET** and begin to take down starting at **4:45pm ET**.

**WHO:** The marketplace will feature 15 high-growth companies and partners showcasing their quality services and products, including Intuit, Bank of America, and Santander Bank.

**WHERE:** The BGM will take place in the pre-function area of the Hyatt Miami Downtown. See the <u>floor plan here</u> to find the pre-function area.

**MATERIALS:** All exhibitors will be equipped with a 6' table with 2 chairs, a tablecloth, and 1 electrical outlet. The booth must be staffed by at least 1 person at all times and should be set up with promotional items to highlight your company's products/services (e.g. printed materials, branded table cloth, banner, company swag, etc.). Businesses are responsible for providing and transporting their own promotional materials.
